The Process

A Selection Committee, with members representing charity-based organizations, businesses and government will review each application. A nominee must be a resident of Lakewood or a non-resident whose work impacts the Lakewood community.

Completing the Form

- Do not exceed word count when addressing the nominee's attributes as they relate to the specific three criteria. You may submit supporting documentations.
- Provide specific examples of your nominee's service. You may also include newspaper clippings or letters of thanks from someone the nominee has helped.
- All fields must be filled out or the application will not be accepted.
- Honorary and past members ARE eligible for consideration; however, current or active members of Lakewood Women's Club are not eligible for consideration.
- Include a high resolution photo of nominee along with nomination form.

The Criteria

Award recipients will be considered based on the following three criteria:

Criterion 1: Impact of Contribution

The nominee has taken the initiative to start special projects in her community that involve others, or has the possibility in the future of encouraging others to contribute.

Criterion 2: Enthusiasm /Commitment

The nominee possesses superior drive or determination. There are specific attributes that make her stand out.

Criterion 3: Leadership

The nominee assumes a leadership role in community activities. She has the ability to inspire volunteering, individuality, and being a diligent worker.
